An applicant who is currently working as a Principal/TIC/Vice Principal should have the relevant portions along with supportive certificates/testimonials/documents authenticated by the President of the concerned Governing Body/Administrator. In other cases, the concerned Principal/TIC/Vice Principal is also competent to authenticate a candidate's credentials in so far as College related performance is concerned.

Applicants against WBCSC's Advertisement No. 01/2022 for the post of Principal must submit the duly filled in Table 2 (Academic / Research Score) with score calculation along with the proforma for general information and academic background (along with the print out of online application form) to the Commission's office by 24/06/2022 (4 PM). The Academic and Research Score is a crucial component of the eligibility-cum-selection criteria, and therefore, accuracy in filling up the proforma for calculating Academic and Research Score is very important for one's candidature. Candidates are requested to read the following instructions and the format carefully before filling in the proforma.

- No column should be left blank. Please write 'NA' in the column not related to you.
- Attach verifiable documents in exactly the same sequence as of the proforma for calculating Academic / Research Score in favour of your submission/s, such as Certificates from proper authority, Papers published etc. (self-attested photo copies only). HOWEVER, PLEASE DO NOT ENCLOSE PHOTOCOPIES OF THE ENTIRE published work. Only those pages that reveal the author's name(s), the ISSN/ISBN no. etc. should be enclosed.
- Original Testimonials/documents should be produced before the interview board. It may be noted that failure to produce original documents may lead to the cancellation of candidature. The published work in original should also be brought for perusal by experts during interview.
- All entries must be made by the candidate himself/herself in his/her own handwriting.
- Any wrong or unauthenticated declaration will be dealt with as per rules and may lead to cancellation of candidature.
- Calculation of scores must be done in accordance with the instruction/s given in each item.
- A MINIMUM ACADEMIC / RESEARCH SCORE OF 110 IS REQUIRED IN ORDER TO ATTAIN ELIGIBILITY.
- The cut-off date for all items of qualification and experience, including publication, shall be 10/06/2022.

Joint Projects: Principal Investigator and Co- investigator would get 50% each

Note:

- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned
- The research score shall be from the minimum of three categories out of six categories
