Sub.: Submission of memorandum by the All Bengal Principals' Council on behalf of the Principals of colleges across the country

Ref.: Formation of Pay Review Committee as per UGC Notification No. F.1-2/2016(PS/PRC), dated 09.06.2016

Respected Sir,

In pursuance with my earlier communication dated 15/06/16 (copy attached), I wish to appraise you the following on behalf of the Principals of the colleges in West Bengal for your kind perusal:

- 1. That the College Principals in West Bengal happen to be the Head of the Institutions of Higher Learning which take care of Higher Education beyond 10+2 level including academic discourse of undergraduate and postgraduate studies, and research activities. The Principals of these institutions of higher learning play the dual role of academic and financial administrators in addition to their normal duties of overseeing both policy matters and the execution of day to day activities of the institutions. The Principals are also endowed with the responsibility of acting like an interface between the Affiliating University and the Government for properly implementing the policies of the Government pertaining to Higher Education in the light of modes and means prescribed by the Affiliating Universities. As a result, the Principals are bound to make compromise on personal issues and family matters for the noble cause of expansion of higher education in the country.
- 2. That the Principals were placed in the Pay Band of Rs. 37400-67000 along with the Associate Professors with only one difference: the Principals were allowed AGP of Rs.10000.00 per month against that of Rs. 9000.00 prescribed for Associate Professors. In addition, the Principals were allowed to draw a sum of Rs.3000.00 per month as Special Allowance. Altogether, the Principals are entitled to a pay in the present system at the entry level of Rs.4000.00 more than that of Associate Professors with limited and highly structured kind of responsibilities. The Principals, therefore, sought justice against the inappropriate consideration with respect to the Pay and Allowances of the Principals as per UGC Pay revision, 2006.
- The Principals must therefore be awarded with a separate package of pay and allowances in commensuration of their duties
  and responsibilities without prejudice of any kind of any other academic staff in the institutions of higher learning.
- 4. The Principals' representation must duly be considered before arriving at any resolution with respect to the proposed pay and allowances of the Principals, the custodians of Higher Education Institutions in the country.

Under the circumstances, may I request you to kindly allow the Principals' representation before the Pay Review Committee as was the case during the last pay revision vide UGC Notification bearing No. F.1-2/2008(PS), 30.10.2009 (copy attached).

Awaiting your appropriate action.
